LWVFA Members Share Their Thoughts About Voting

A Family Tradition - Elizabeth Vanderberg

My mother, Kay Gardey Vandenberg, joined the League of Women Voters Fairfax City in 1966 when I was six. She was a stay-at-home mom, but the League quickly became her full-time job. Instead of teaching me to cook and sew, she recruited me to collate, staple, stuff envelopes and best of all, run the mimeograph machine. We even had a voting machine in our garage for voter education activities. Registering to vote for the first time was more exciting than celebrating my birthday. When I found out that people didn't vote I was incredulous. Not voting? Wasn't that against the law? I'm profoundly grateful for having grown up at the feet of League members and to carry on the family tradition. Registering voters—especially high school students— is a blast!

Perfect Voting Record - Kathleen Pablo

My father, the son of immigrants, was – like his parents – intensely patriotic. He enlisted in the Army, and never once in his life missed voting in an election. On his deathbed, he realized it was an election day. Too late to apply for an absentee ballot, I went to the local Registrar. She dispatched an election officer to their Alexandria home, and the precinct worker brought a ballot to his bedside. When the officer left, we said, "Dad, you've kept your perfect record!" He smiled and responded, "Now I'm square with my God and my country."

Example speaks more eloquently than exhortation. His children (and now his grandchildren) never miss voting, many served in the military, and we laugh about "voting for Dad."

Voting Every Time - Natalie Lorenz Anderson

I turned 18 several months after the 1980 general election, so I could not vote in this important presidential race. However, as a college freshman in Massachusetts, I enjoyed working actively canvassing for John Anderson's campaign, who by then was running as an Independent candidate. I felt like I was at least part of the democratic process even though I could not vote. I haven't missed a major primary/presidential election since then. Once I moved to Virginia in 1999

and learned that we have annual elections and ballot items, I have voted every year.

Why I Vote - Donna Schutz

Voting is a privilege and a responsibility. It is also the way to make your voice heard and help create any changes you think are needed. So many times, I have heard folks say, "I don't like what is happening. I am not going to vote." I feel that this attitude does not promote democracy. When we are most discouraged, we must step up and be part of the solution. Voting is an important way to do this. Not everyone is comfortable being outwardly politically active, but voting is what we can do privately to support our country. Every vote REALLY does count.

Voting in Every Election - Karen Gatz

I am always astonished and also somewhat dismayed when citizens say they don't vote. When I ask why, they often say they only vote for president or voting doesn't matter or they don't want to be called for jury duty. Amazing. I was lucky enough to be raised in a family that stressed the importance of voting. I've voted in (almost) every election but only gradually came to realize the importance of every election.

Like many people, I focused on presidential and congressional elections, thinking federal offices were most critical to the country and to my life. Gradually and as times changed, I came to see the crucial importance of voting in state and local elections, both primary and general elections. Elected officials at the state and local levels decide the mundane and the critical – paving roads and education policy, health initiatives and environmental protections, and expanding or restricting voting rights. It all happens at the state and local level. Those are the actions that affect daily life much more than what the president or the Congress does. State and local elections often include important ballot measures, even constitutional amendments, as well that could be in effect for generations. It is critical that strong and thoughtful candidates are chosen in primary elections and are carefully considered in the general election. Those are some of the reasons I vote in every election.

Monthly Program Changes and Topics

School Bond Referendum

Fairfax County voters will see a \$435 million bond for Fairfax County Public Schools (FCPS) on their ballots this fall. A bond allows Fairfax County to borrow funds and spread the cost over years similar to a mortgage on a house. By law, the funds must be used only as stated on the ballot.

If approved by a majority of voters, FCPS will use the funds to:

- Renovate seven elementary schools.
- Plan and design renovations of eight elementary schools and one middle school.
- Complete three modular relocations.
- Install school security vestibules at more than 25 schools.


The renovation projects will upgrade the safety, environmental, electrical, security, and telecommunications systems of school buildings, and bring aging school facilities into full compliance with legal requirements.

Our stated position on school bonds in Here We Stand (lwv-fairfax.org/league-positions) is as follows:

The LWVFA believes that the sale of bonds by political jurisdictions is an appropriate method of financing capital improvements, including the construction and renewal of school facilities. (1980; 2008) Factors to be considered when evaluating proposals for bond funding include:

- Whether the project is included in the Capital Improvement Program.
- Whether the project addresses a high-priority need.
- Whether the cost is greater than can be financed from the General Fund.
- Whether the life of the facility is at least equal to the payback period of the bonds.
- Whether it is appropriate for future users to share the cost of the facility.
- The fiscal impact of the bonded indebtedness on the County/City budget. (1991)



People often make it a priority to vote in Presidential elections; however, fewer people tend to vote in state and local elections, even though these officials have far greater influence over our daily lives and our communities. This fall, Virginia voters will elect the entire General Assembly. Fairfax County and Fairfax City voters will elect the Commonwealth's Attorney, Sheriff, and Clerk of the Circuit Court. In addition, Fairfax County voters will elect School Board members and vote on a School Bond. The towns of Clifton and Vienna will elect their Mayors and Town Council members.

We need to:

- Share information about League resources to help voters get the facts and make important voting decisions.
- Urge voters to cast their votes.

We have included information on all the local candidates and asked each to provide additional information and answer several

questions on their policy positions. Vote411 allows voters to compare the answers of the candidates as well as see who has declined to provide information. This resource is improving every year, and is one of the few places to see comprehensive information on local candidates in one place.

Candidate Forums

Watching candidate forums is an excellent way to learn more about the candidates and the issues. Consider watching candidate forums with friends and family. Host or attend a viewing party. Discuss the forum and candidate responses with others. Talk about the issues and find out how your views compare with others. Get a range of perspectives on the issues.

Domestic Violence: What Do You Know? Why Should You Care?

Domestic violence is not due to abusers losing their tempers, being drunk, or on drugs. Nor is it due to anything the victims do or say. Many people think DV only causes physical injuries. However, the abuse can also be emotional, sexual, psychological, or financial. In addition, stalking, cyberstalking, and threats are forms of DV.

Over 90 percent of DV victims are women who are abused by male partners. It is also interesting that "[within] the LGBTQ community, intimate partner

violence occurs at a rate equal to or even higher than that of the heterosexual community. LGBTQ individuals may experience unique forms of intimate partner violence as well as distinctive barriers to seeking help due to fear of discrimination or bias." https://ncadv.org/blog/posts/domestic-violence-and-the-lgbtq-community

On average, nearly 20 people per minute are physically abused by an intimate partner in the United States. In a year, this "equates to more than 10 million women and men." https://ncadv.org/statistics

Consider the following statistics about intimate partner-related homicides reported by the Virginia Department of Health:

- More than 30% of Virginia's homicides are domestic -violence related.
- Women make up 51% of Virginia's population but account for 63% of the people killed by firearms in intimate partner-related homicides.
- About 56% of domestic-violence homicides involve firearms
- About 80% of domestic-violence homicides happen in people's homes.
- About 40% of domestic-violence homicides happen during or after a relationship breakup.
- More than 20% of domestic-violence homicides involve a homicide-suicide.

Unfortunately, adults are not only the DV victims. Children are DV's innocent and vulnerable victims. They are profoundly affected by the abuse of the adult victims, whether they are directly abused, exposed or witness the abuse by seeing or hearing it, or are neglected because of it. In addition, they are often abused by the same males as their mothers. The DV effects on children will be addressed in a future article.


