
## Presidents' Message:

# Sexual Violence: What Do You Know? Why Should You Care?

April is Sexual Assault Awareness Month (SAAM). According to the Fairfax County Office of Family Services, the purpose of SAAM "is to raise public awareness about sexual violence, educate our community on how to prevent it and share resources available to those impacted by sexual assault..." Everyone is affected by sexual assault. This is borne out by the statistics: Nearly 1 in 3 women and 1 in 4 men will be the victim of sexual violence at some point in their **lifetime.**" (Bold marks are in the original text). It is a traumatic, life-changing experience and telling someone about it is frightening. The survivor's physical injury may not always be substantial, but unseen psychological and emotional injuries may be severe. Interestingly, the person doing the sexual assault is a person known to the victim, not a random stranger.

What is sexual assault? According to the University of Colorado Office of Health and Wellness, it includes "any unwanted sexual contact or behaviors that a person did not or was not able to consent to, whether there is unwanted penetration or contact...or unwanted touching of private body parts. Additional forms of sexual misconduct include sexual harassment, exploitation (e.g. sharing nudes, videotaping sexual acts without consent, etc.) as well as intimate partner abuse, such as dating violence and stalking."

The Office states that are five things that everyone should know about sexual assault:

- 1. While sexual assault can happen to anyone, regardless of age, race, gender identity or sexual orientation, it disproportionately affects women, people who identify as bisexual or transgender and young adults. It is a choice to perpetrate sexual assault and never the survivor's fault.
- 2. Consent is key.
- 3. Sexual assault can include a wide range of experiences (as mentioned earlier).
- 4. It can be preventable. We have the opportunity to look out for each other, speak up about sketchy behaviors and situations, and take steps to create a safer community. [All] of us need to work individually and collectively "to build more connected, respectful, and inclusive communities to promote our collective well-

being and protect against the risk of sexual violence. We believe all of our communities will be safer and stronger by making them more equitable for people of all gender identities and sexual orientations, races and ethnic backgrounds, ages, faiths, and abilities."

#### **Local News and the Casino Proposal**

We rarely have a connection between our League studies and real-life local events, but this winter we did have one.

In February, thanks mainly to the *Reston Patch*, but also *The Fairfax Times*, *FFX Now*, *The Gazette*, and *Reston Now*, we woke up to the proposal to build a casino in our county. Michael O'Connell of the Reston Patch followed the money, showing how the property holders and developers contributed to the campaigns of the legislators who would be voting on SB 675.

This bill would add Fairfax County to the five other locations in Virginia that may have casinos if the residents of the county pass a referendum in favor of it. Thanks to local news, we know that the bill has been carried over to the 2025 session. Now that we are no longer surprised, we have time to look with true League civility into the pros and cons of a casino in Fairfax County.

We could start by looking at the Joint Legislative Audit & Review (JLARC) study, <u>Gaming in the Commonwealth</u> (2019), which was conducted at the direction of the General Assembly. We may not all agree about the casino, but we do agree that we should base our opinions on knowledge of the facts.
