### LWVFA Attended the Fairfax County Adult Detention Center Fair

The Fairfax County Sheriff's office now hosts Inmate Resource Fairs twice a year. The Fairfax Area League had its first table at the Fair on March 2. Adarsh Trehan, the League's representative at the Fairfax County Re-entry Council, and Sidney Johnson, Voter Service Coordinator, gave leaflets to the inmates explaining to them the procedures for applying to the Governor for a restoration of voting rights. Adarsh and Sidney spoke to about 40 inmates and also gave leaflets to the other vendors who had tables at the fair. These social service representatives said that they would be glad to have that information to pass on to clients.

The leaflet was designed for the League of Women Voters of Virginia, modified with advice from Carol Noggle and Therese Martin, and updated with information from Lashawnda Singleton, the Restoration of Rights Communications Manager for the Secretary of State for the Commonwealth. Many thanks to everyone who participated in designing and formatting the leaflet. Because of all the hard work in the background, the Fairfax Area League was ready at very short notice to provide this vital information to the inmates.

# **Cortez Will Be Speaker at Fairfax's Annual Meeting**

Edgardo Cortes, Commissioner of the Virginia Department of Elections, has been selected to address the membership. Cortés is no stranger to the elections community, having worked in the field for more than a decade. Before his appointment, he served as deputy secretary of the State Board of Elections.

As the former general registrar of Fairfax County, Cortés was responsible for administering elections in Virginia's largest county until 2011. He began working for the U.S. Election Assistance Commission in 2005, first as the grants director and then as deputy director for policy. Cortés holds a bachelor's degree from Cornell University and a master's degree in political management from George Washington University.

### Earth Day, Every Day

Trees for the Earth. Counting down to its 50th anniversary in 2020, the Earth Day Network aims to plant 7.8 billion trees. Trees help combat climate change, clean the air we breathe, and provide food, energy, and income. Local Earth Day activities, like removing invasive plants in parks and along streams, are listed on the Newtwork's webpage, www. earthday.org.

Native Pollinators. Bees, butterflies, moths, bats, and birds play a critical role in ecosystems, valued at \$9B to U.S. agriculture according to the Lady Bird Johnson Wildflower Center. Yet pollinators are in severe decline, such as the monarch butterfly's 96 percent drop to 35 million over the last 20 years. Native pollinators can be two to three times more effective at pollinating crops than non-native honeybees. Native pollinators need native plants; you can help by planting habitat. See http://www.xerces.org/pollinator-conservation-resources-us-and-canada/ for a list of recommended regional native plants.

**Drug Disposal.** Prevent pharmaceuticals from getting into our drinking water by disposing of your expired prescription medications at local collection points. Look for secure green bins soon to arrive at the Mason District, Mt. Vernon District, Reston District, and West Springfield Station police stations. Walgreens also plans to accept unused medications in select stores.

## Two New LWVUS League Positions Adopted

### Constitutional Conventions under Article V of the U.S. Constitution

In January the League of Women Voters Board announced a new position calling for safeguards to govern the constitutional convention process. State Leagues can use this new position, as well as the new position outlining considerations for evaluating constitutional amendment proposals, to address the ongoing debates in many legislatures regarding constitutional conventions, in particular as they related to the Balanced Budget amendment.

### Position on Constitutional Conventions under Article V of the U.S. Constitution (Adopted January, 2016)

The League is concerned that there are many unresolved questions about the powers and processes of an Article V Constitutional Convention. The League believes such a convention should be called only if the following conditions are in place:

- a) The Constitutional Convention must be transparent and not conducted in secret. The public has a right to know what is being debated and voted on;
- b) Representation at the Constitutional Convention must be based on population rather than one state, one vote, and delegates should be elected rather than appointed. The delegates represent citizens, should be elected by them, and must be distributed by U.S. population;
- c) Voting at the Constitutional Convention must be by delegate, not by state. Delegates from one state can have varying views and should be able to express them by individual votes;
- d) The Constitutional Convention must be limited to a specific topic. It is important to guard against a "runaway convention" which considers multiple issues or topics that were not initiated by the states;
- e) Only state resolutions on a single topic count when determining if a Constitutional Convention should be called. Counting state requests by topic ensures that there is sufficient interest in a particular subject to call a Convention and enhances citizen interest and participation in the process; and
- f) The validity of state calls for an Article V Constitutional Convention must be determined by the most recent action of the state. If a state has enacted a rescission of its call, that rescission must be respected by Congress.

### Considerations for Evaluating Constitutional Amendment Proposals

The League of Women Voters Board also announced a new position outlining considerations for evaluating constitutional amendment proposals. State Leagues can use this new position, as well as the new position calling for safeguards to govern the constitutional convention process, to address the ongoing debates in many legislatures regarding constitutional conventions, in particular as they related to the Balanced Budget amendment.

### Considerations for Evaluating Constitutional Amendment Proposals (Adopted January, 2016)

The League will only support a proposed amendment to the U.S. Constitution if it advances and conforms to an LWVUS position.

In addition, the League believes the following should be considered in identifying an appropriate and well-crafted constitutional amendment:

- a) Whether the public policy objective addresses matters of such acute and abiding importance that the fundamental charter of our nation must be changed. Amendments are changes to a document that provides stability to our system and should be undertaken to address extreme problems or long-term needs.
- b) Whether the amendment as written would be effective in achieving its policy objective. Amendments that may be unenforceable, miss the objective, or have unintended consequences may not achieve the policy objective.
- c) Whether the amendment would either make our political system more democratic or protect individual rights. Most adopted amendments have sought to make our system more representative or to protect the rights of minorities.
- d) Whether the public policy objective can be achieved by a legislative or political approach that is less difficult than a constitutional amendment. In order to expend resources wisely, it is important to consider whether legislation or political action is more likely to succeed than an amendment.
- e) Whether the public policy objective is more suited to a constitutional and general approach than to a statutory and detailed approach. It is important to consider whether the goal can best be achieved by an overall value statement, which will be interpreted by the courts, or with specific statutory detail to resolve important issues and reduce ambiguity.
