### **COLLECTION OF PERSONAL INFORMATION**

We collect personal information directly from you, for example through a web form or during registration. Personal information we collect directly from you may include first and last name, email address, and cell phone number. Our website may use technologies such as cookies, web beacons, pixels, and other similar technologies to automatically collect certain information from your device including, for example, your IP address, date and time of your visit, browser and operating system information, referring website address, and other information about how you interact with the website.

Our email and texting campaigns may also use tracking technologies such as web beacons, pixels, and other similar technologies to automatically collect certain information such as your IP address, browser type and version, and email engagement statistics.

### **USE OF PERSONAL INFORMATION**

We may use information collected about you for any lawful purpose, including the following:

- To provide you with reminders about voting and voting information.
- To provide you with information from our website.
- To comply with the law and to maintain the security of our website.

### **DISCLOSURE OF PERSONAL INFORMATION**

We will not share your personal information for non-League activities.

We may share information, if necessary, with:

- Third-party service providers to assist us with providing and marketing our products and services, data hosting services, analytics services, and email service providers.
- Constant Contact, to send email marketing and text message communications. For more

- Law enforcement agencies if necessary to comply with applicable laws and regulations, to
  respond to a subpoena, search warrant or other lawful request for information we receive, or to
  otherwise protect our rights or the rights of third parties, or to protect the safety or security of
  any person or entity.
- Your consent or as otherwise disclosed at the time of data collection or sharing.

We may share information that has been de-identified or aggregated without limitation.

We may also work with third parties that collect data about your use of our website and other sites or apps over time for non-advertising purposes. We use Google Analytics and other third-party services to improve the performance of the website and for analytics and marketing purposes. For more
